IL Department of Ag

Fall Covers for Spring Savings- The IL Department of Ag offered a \$5.00/acre rebate on crop insurance to producers implementing cover crops. This is the second year that the program has been offered with over 133,000 acres available for a rebate. The program was so successful that all of the acreage was accounted for in the first 24 hours of the application period. NRCS/FSA

The USDA recently announced its goal to enroll up to 4 million new acres in CRP by raising rental payment rates and expanding the number of incentivized environmental practices allowed under the program. We know that there will be an increase in the soil rental rate for all lands that were offered and accepted in FY2021. Additionally, those practices that are environmentally sensitive (Continuous Sign Up) will see additional Practice Incentive Payments. It will take some time for the National Office to implement these changes in the software and the County Offices will have to re-run all offers currently in the system. Currently, the General and Continuous signups are still open for enrollment. See attached fact sheet for more information CRP Program changes.

STAR- Saving Tomorrow's Ag Resources

The STAR initiative is an innovative ranking tool to help farm operators evaluate conservation practices on specific fields. This tool helps recognize big strides in conservation and allows landowners to measure their progress toward more sustainable ag systems. STAR assigns point values to different farming activities with the highest point values being aligned with the Nutrient Loss Reduction Strategy. Each field gets a score between 1-5 stars. This year, the star program gave out incentive payments to applicants wanting to increase their STAR ranking from crop year 20-21. Out of the 30+ applicants in the state of Illinois, 5 were from Henry County! Out of those 5, 4 applicants were able to receive funding.
